- (2) Price reflects the weighted average price of the day's high and low prices of Curtiss-Wright's common stock as reported on the New York Stock Exchange on the dates the Director earned his or her compensation back in February 2006, correcting a clerical error whereby the record keeper failed to correctly account for the Company's stock split prior to the date of the original issuance.
- (3) Number of shares reflects a 2 for 1 stock split paid on April 21, 2006.
