- (2) The number of shares is arrived by dividing the closing price of the Issuer's securities on February 10, 2015 into \$90,000, the amount of the stock award granted to the Issuer's non-employee directors.
- (3) Price is based on the closing price on of the Issuers securities as reported on the New York Stock Exchange for February 10, 2015, the date the award was approved by the Issuer's Board of Directors
