The restrictions on these shares lapse upon the shorter of (a) three years from the date of grant or (b) until such time as the service of the recipient as a Non-employee Director of the Company shall have ended by reason of his or her (i) death or disability or (ii) failure to be reelected.
- (2) The number of shares is arrived by dividing the closing price of the Issuer's securities on February 5, 2020 into \$125,000, the amount of the stock award granted to the Issuer's non-employee directors.
- (3) Price is based on the close price for the Registrant's common stock on February 5, 2020 the date the reporting person earned annual award.
